



Chariot Resources at Two Global Investment Conferences; Final Draft of ESIA Has Been Received

TORONTO, ONTARIO--(September 9, 2009) - Chariot Resources Limited (TSX:CHD) announced the President and CEO Ulli Rath would be presenting at the Rodman and Renshaw Global Investment Conference on September 10th in New York. This Conference is well attended by the investment community and the keynote speaker at this year's conference is former Federal Reserve Chairman Allan Greenspan.

On September 12th, Chariot will host a trip for Mining Analysts to its 70% owned Mina Justa Copper Project in Peru.
